

### **SERVICE ACADEMY ELIGIBILITY**

Each applicant for a service academy nomination must meet the following eligibility requirements as of July 1 of the year of admission to an academy:

**Age**: At least 17 years old, but not yet 23 years old, age 25 for the Merchant Marine Academy. **Citizenship**: Must be a U.S. citizen and a permanent resident\* of the Commonwealth of Pennsylvania.

\*Dependents of active-duty service members stationed in Pennsylvania who are permanent residents of another state may apply IF they are using their Pennsylvania address in academy applications.

**Marital Status**: Unmarried, not pregnant, and have no legal obligation to support children or other dependents.

All application materials must be attached to your online application by 5:00 p.m. (EDT) on Friday, September 20, 2024. Please do not mail or fax your application materials to our office, by doing so could result in processing delays and missed deadlines.

You should begin the application process as soon as possible by contacting the service academies of your choice.
